**PROTEKT FILM CARE**

No special care is necessary for Protekt PPF as it is virtually self-healing. Light scratching will be eliminated over time.

When washing your vehicle, avoid using a high pressure washer with the nozzle any closer than 36" from the surface and edge of the film to avoid peeling or damaging the film's protective surface.

Automotive wash and wax products can be used to clean areas where Protekt PPF Film has been installed.

## WARRANTY COVERAGE AND TERMS

**Warranty Coverage** - Madico®, Inc. (Madico) warrants professionally sold and installed Protekt PPF products (the “Products”) against, cracking, bubbling and yellowing caused solely by defects in manufacturing or materials. If any Product fails during the warranty period, Madico will have an authorized installer remove the old film and replace it with new Product. Madico will reimburse the installer for reasonable labor costs to complete the warranty work.

**Who is Covered** - This warranty extends only to the registered owner of the vehicle at the time the Product was purchased and installed. If the Product was installed by an auto dealer prior to initial new vehicle sale, owner must obtain a bill of sale from the auto dealer that includes a reference to the Product to serve as proof of purchase.

**The Period of Coverage** - The warranty is for 7 years from the date of installation. This warranty is non-transferable, and terminates automatically upon any sale or transfer of the vehicle.

**What is not covered** - Madico shall not be liable and hereby disclaims all liability for any loss, damage, expense, or cost caused or partially caused due to: improper product installation, accidental or negligent misuse, improper product application, mis-alignment, improper product care/cleaning or abuse; improper alterations of original manufactured product, exposure to corrosive or abrasive materials, damage from direct impact to the vehicle from road debris or any other object, failure due to structural defects in the surface to which the product is applied, application on a re-painted surface, any other acts, occurrences, defects, faults, color change, or damages not specifically caused by the actions or inactions of Madico.

**THIS WARRANTY DOES NOT APPLY TO VEHICLES USED FOR COMMERCIAL, FLEET, FOR PROFIT OR RENTAL SERVICES OR TO BE USED ON A RACETRACK.**

**Other limitations** - the foregoing is in lieu of all other express or implied warranties, including but not limited to the implied warranties of merchantability and fitness for a particular purpose. Madico shall not be liable for the loss of use or any other incidental, special, consequential, punitive or other similar damages incurred by the original purchaser, even if Madico is advised of the potential for such losses. Some states and provinces do not allow the exclusion or limitation of incidental, consequential or punitive damages, so the above limitations or exclusions may not apply. This warranty gives you specific rights, and you may also have other rights, which may vary by state or province.

## CONSUMER WARRANTY CLAIM PROCEDURE

This warranty is limited and is the eligible Madico film owner's sole and exclusive remedy. Should the Product fail to meet the terms of this warranty, contact the Madico Warranty Department at [warranty@madico.com](mailto:warranty@madico.com), to initiate a claim. An inspection of the vehicle may be required. Madico will review a warranty claim within 45 days of receiving ALL proper documentation. Madico will authorize completion of warranted work if a claim is deemed valid. Once a claim is approved, the original purchaser may obtain replacement and installation of the Product at any participating Madico Protekt dealer in the United States or Canada. The obligation of Madico under this warranty includes the replacement of the non-conforming Product and reasonable labor to remove and reinstall the film. The replacement product will be provided to the installer conducting the removal and reinstallation as approved by Madico under the terms of this warranty.

**PURCHASER MUST SUPPLY THE ORIGINAL RECEIPT OF INSTALLATION ALONG WITH THIS COMPLETED MADICO WARRANTY. A PRODUCT ROLL SERIAL NUMBER IS REQUIRED FOR WARRANTY PROCESSING. FAILURE TO PROVIDE VERIFYING DOCUMENTATION WILL RESULT IN CLAIM DENIAL.**
